A Moving experience... Many thanks to all who pitched in to move Dale & Louise to their beautiful new apartment at Heartsworth in Vinita!





















As most of you know, I have been dealing with health issues. Unfortunately, my kidney deterioration has advanced to end state renal failure. While dialysis treatment three days a week has brought some relief, dialysis is successful for only about five years. After that, I will likely develop a degenerative bone disease that ultimately leads to death in about two years.

Please don't misunderstand my intentions in this missive. I am not asking anyone for one of their kidneys. However, our church has been a strong supporter of blood donations. It occurs to me that we should be just as supportive of kidney donations.

If you decide to volunteer to donate one of your kidneys prior to your death, please be reassured that will only be considered if doctors conclude that removing your kidney will not endanger your life.

If you are not of a mind to donate a kidney at anytime in the near future, you do have the option to donate your organs after death. At that time, not only will your kidneys be removed after your passing, but you can also designate that any other key body parts such your liver and or your eyes, to people who desperately need them.

Thank you for your consideration of these options, and may God continue to bless each and every one of you.
